riders on weekdays opened Transit. That is 91% more than last year in November with 339 riders.

GO trips were started by METRO riders, receiving step-by-step navigation. That's a 126% increase from the 1829 users of last year. Users tapped on routes 2, 3, & 1 the most.



231%



riders answered Rate-My-Ride questions in November, up from 2818 in 2023. That's a 231% increase. We received an average rating of 4.6/5 stars. In November, 25.8 % of METRO riders rated METRO five stars.



tickets were sold in November, compared to 976 in 2023.That's a value of \$4590, compared to \$3368 the previous year. That is an increase of 47% more tickets sold.
