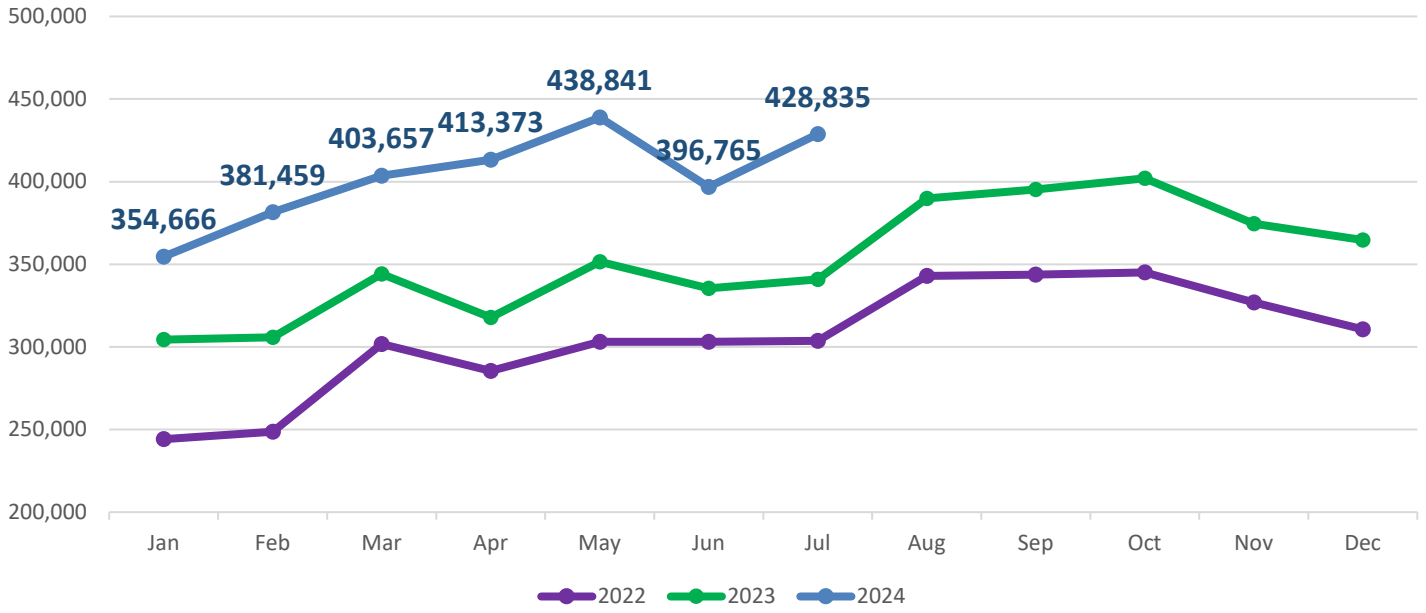

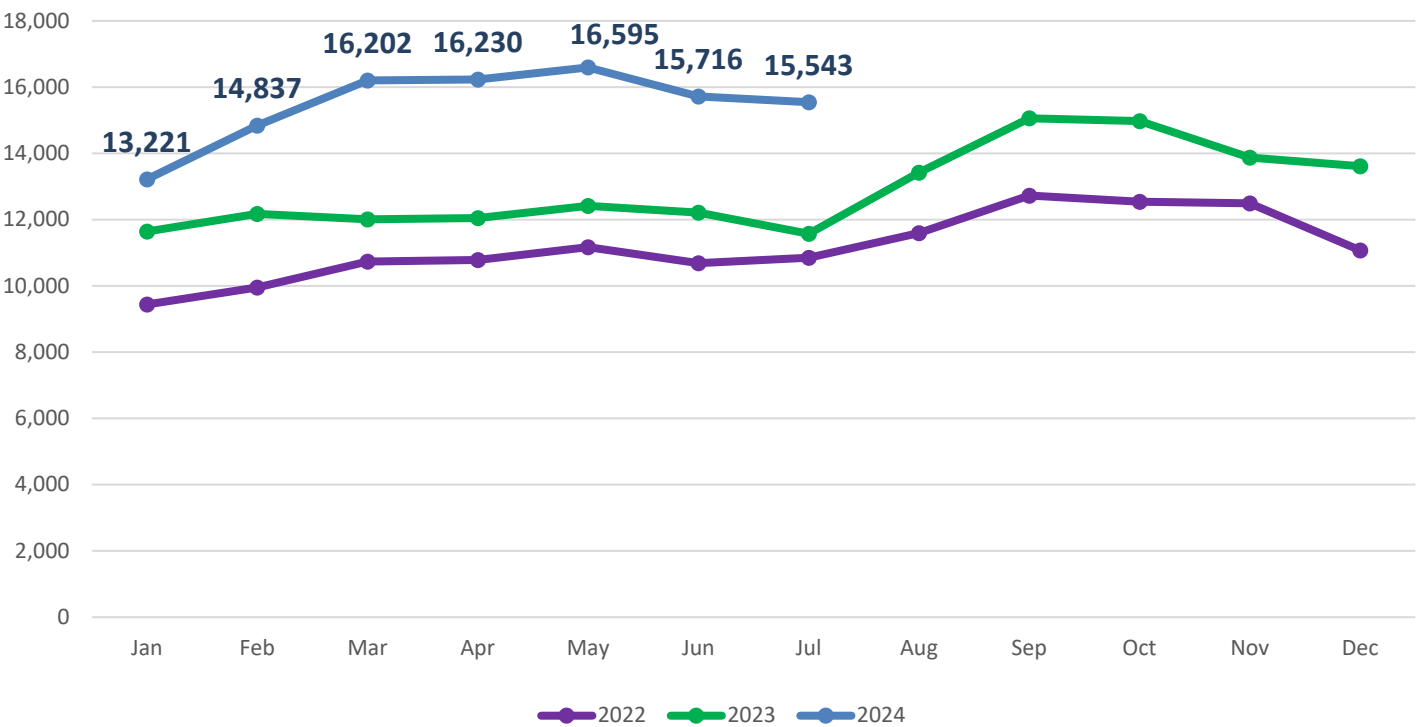

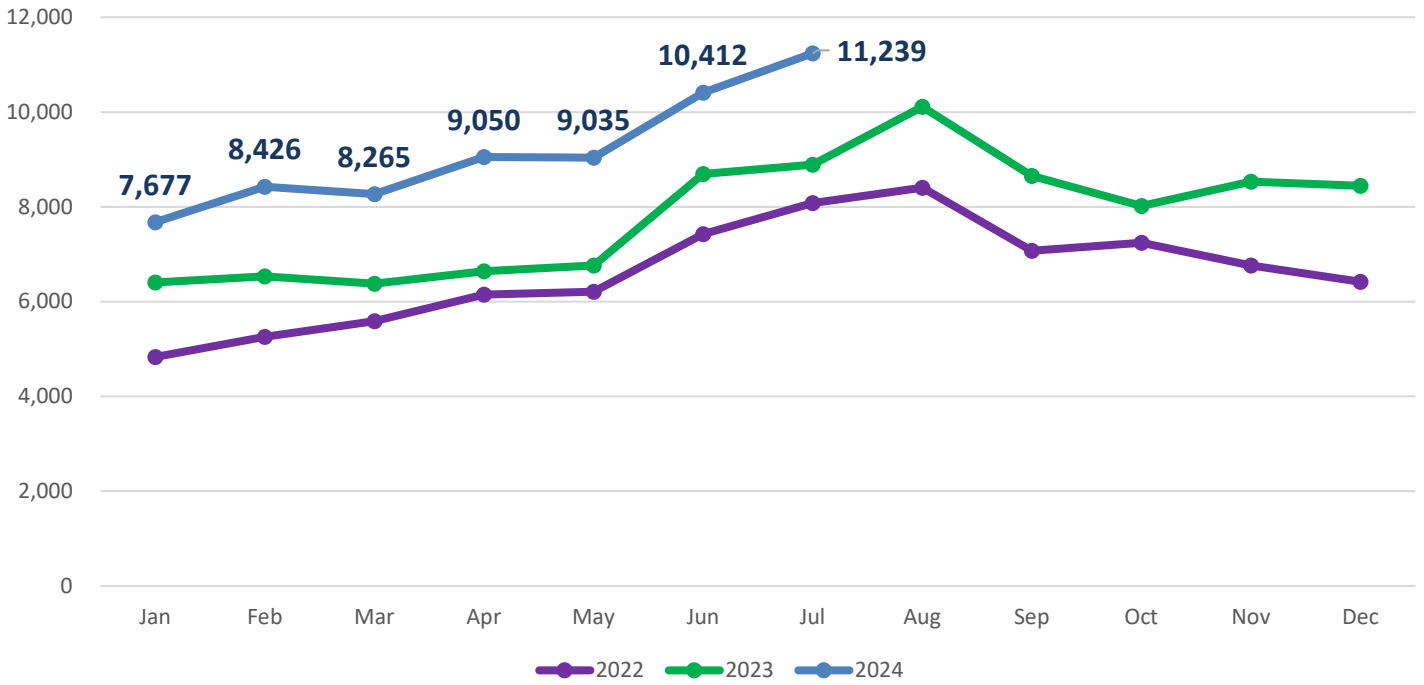
Total Ridership (Combined Demand Response and Fixed Route)



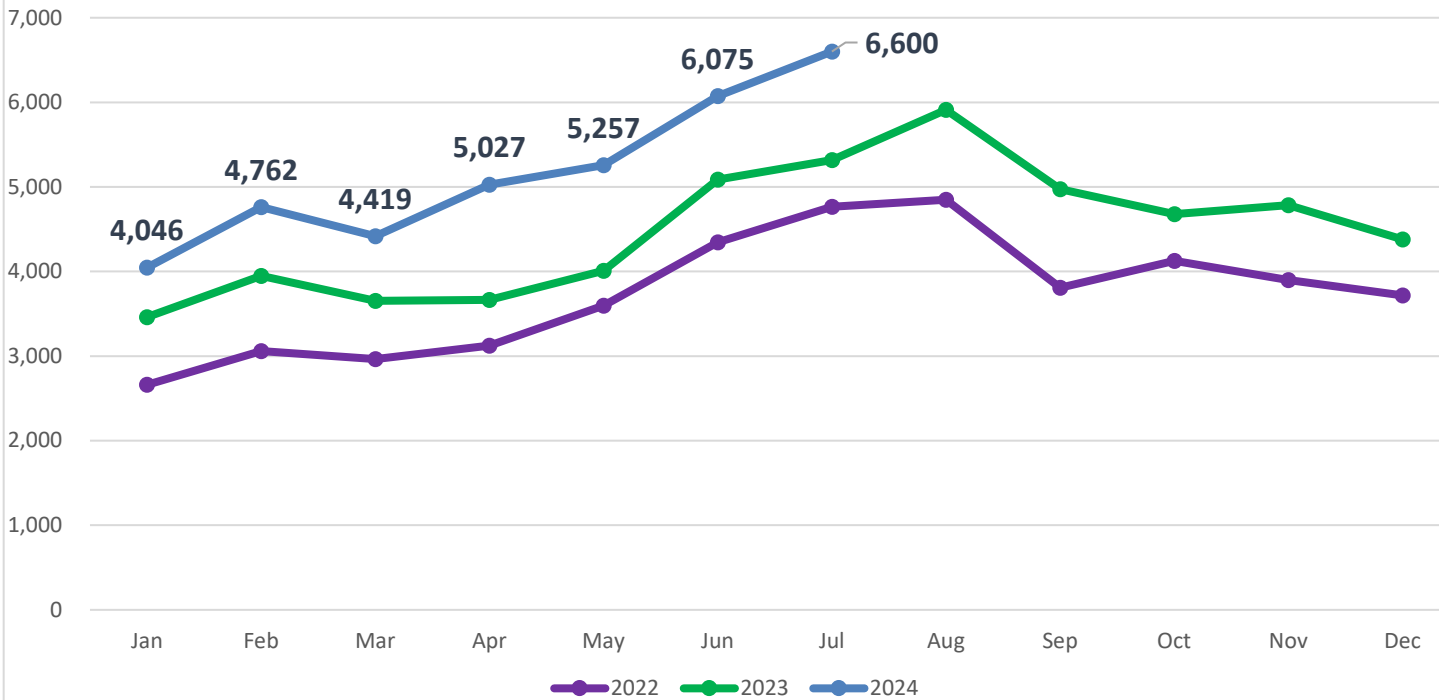
Average Weekday Ridership - Fixed Route



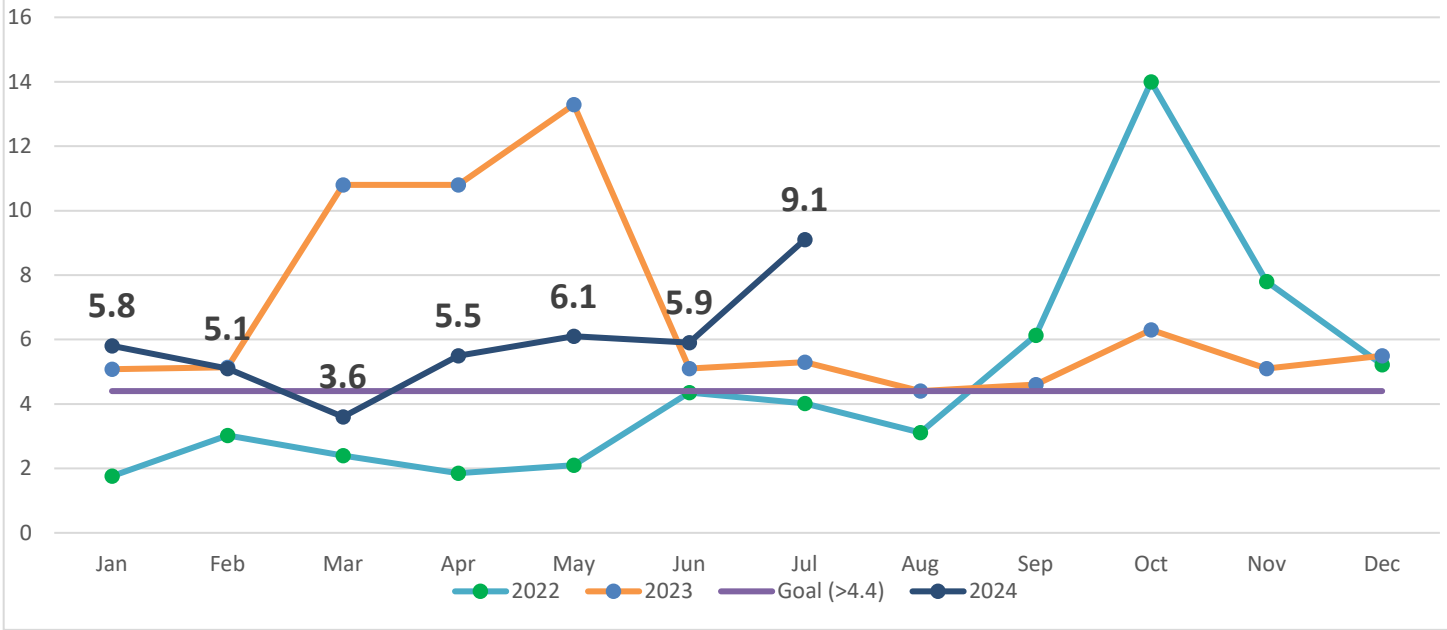
Average Saturday Ridership - Fixed Route



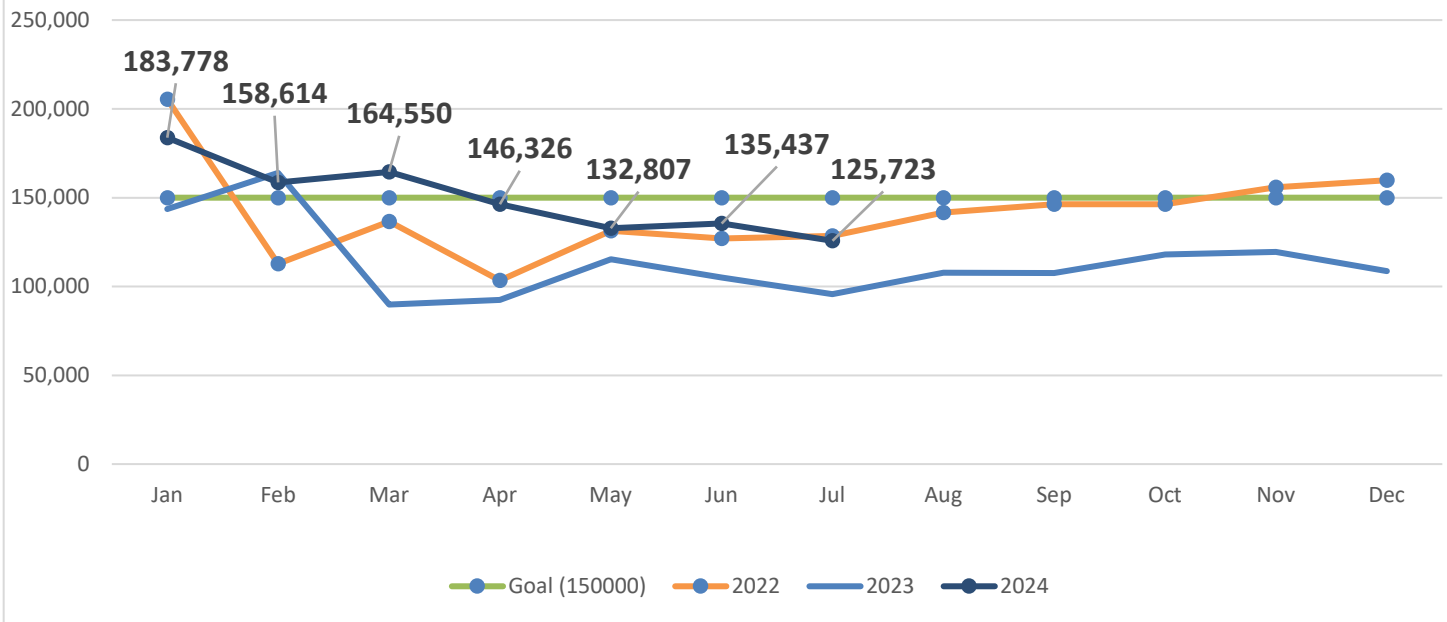
Average Sunday Ridership - Fixed Route
