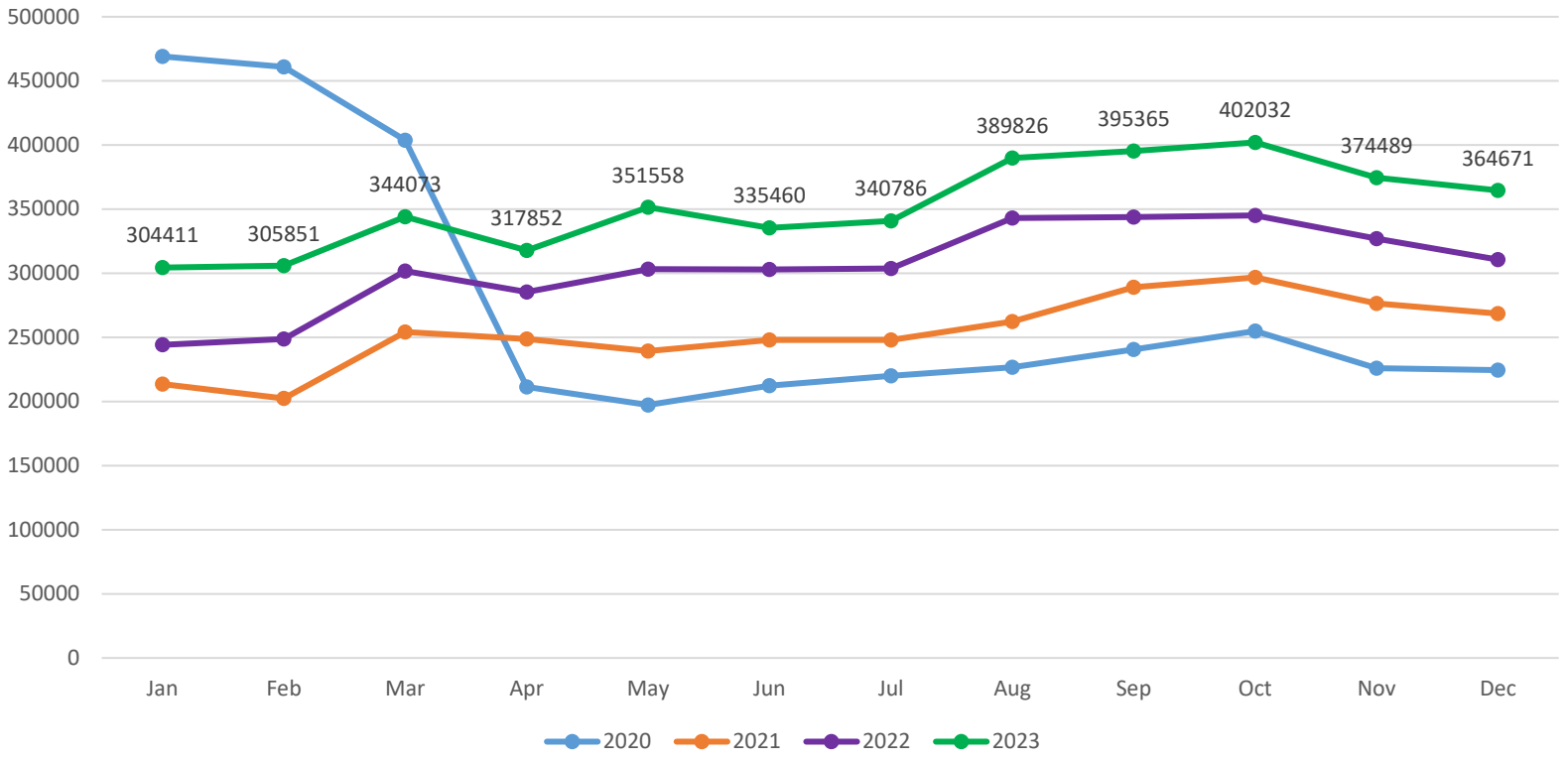

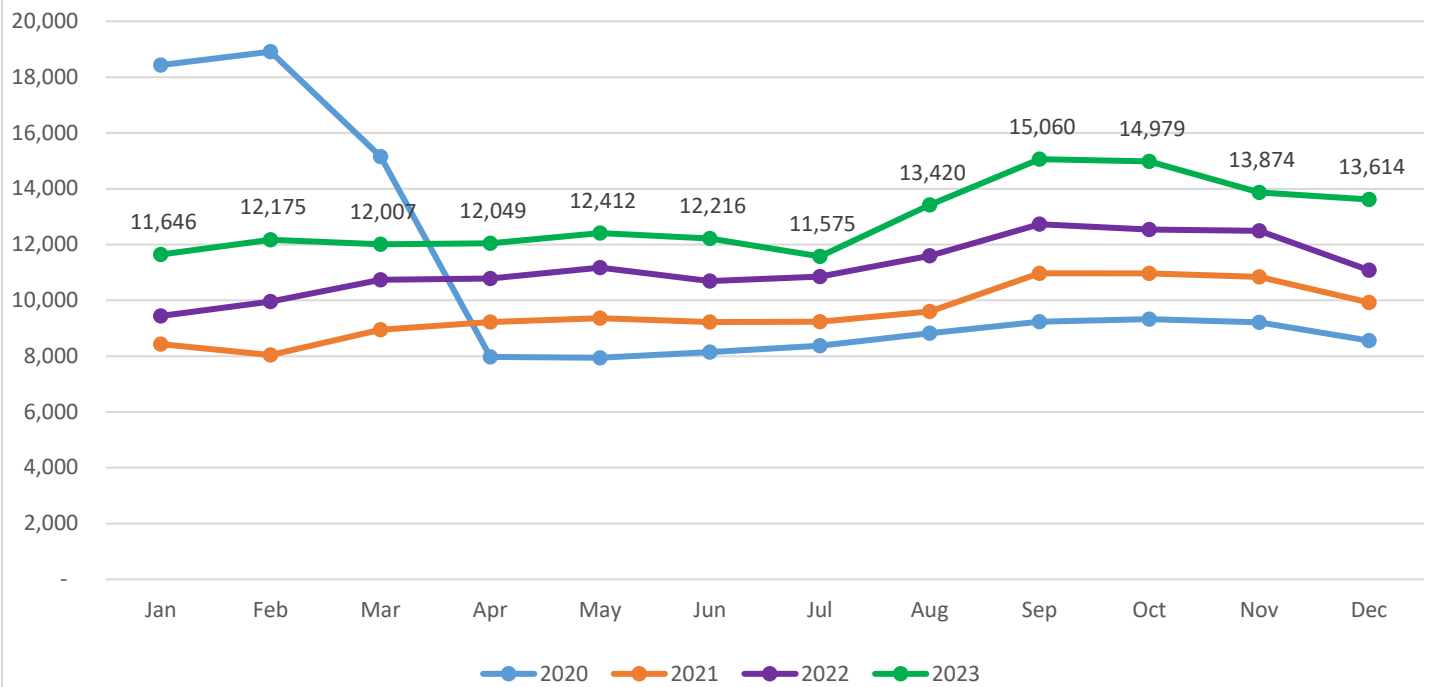

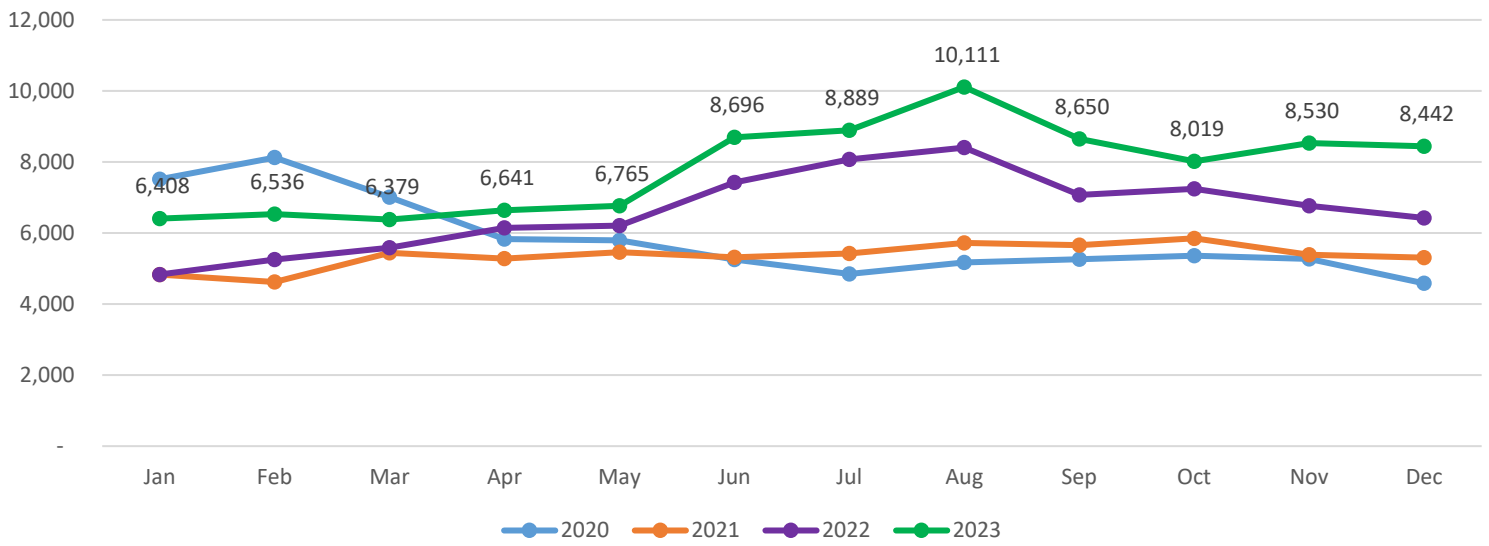
### Total Ridership (Combined Demand Response and Fixed Route)



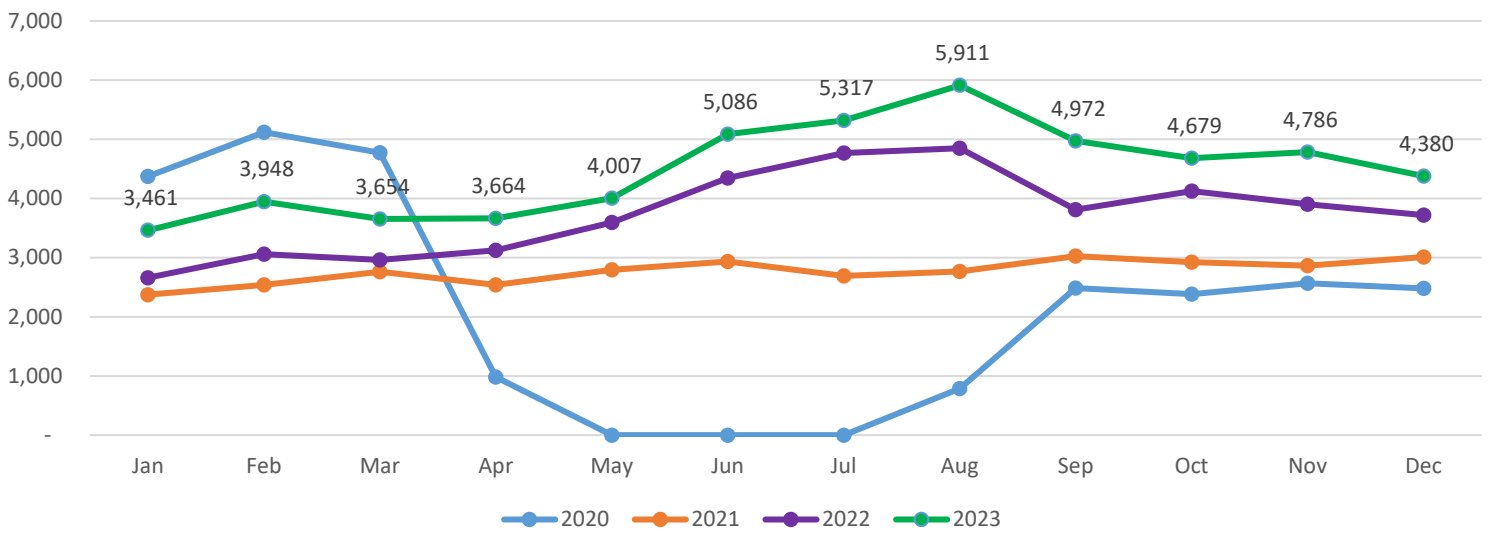
### Average Weekday Ridership - Fixed Route



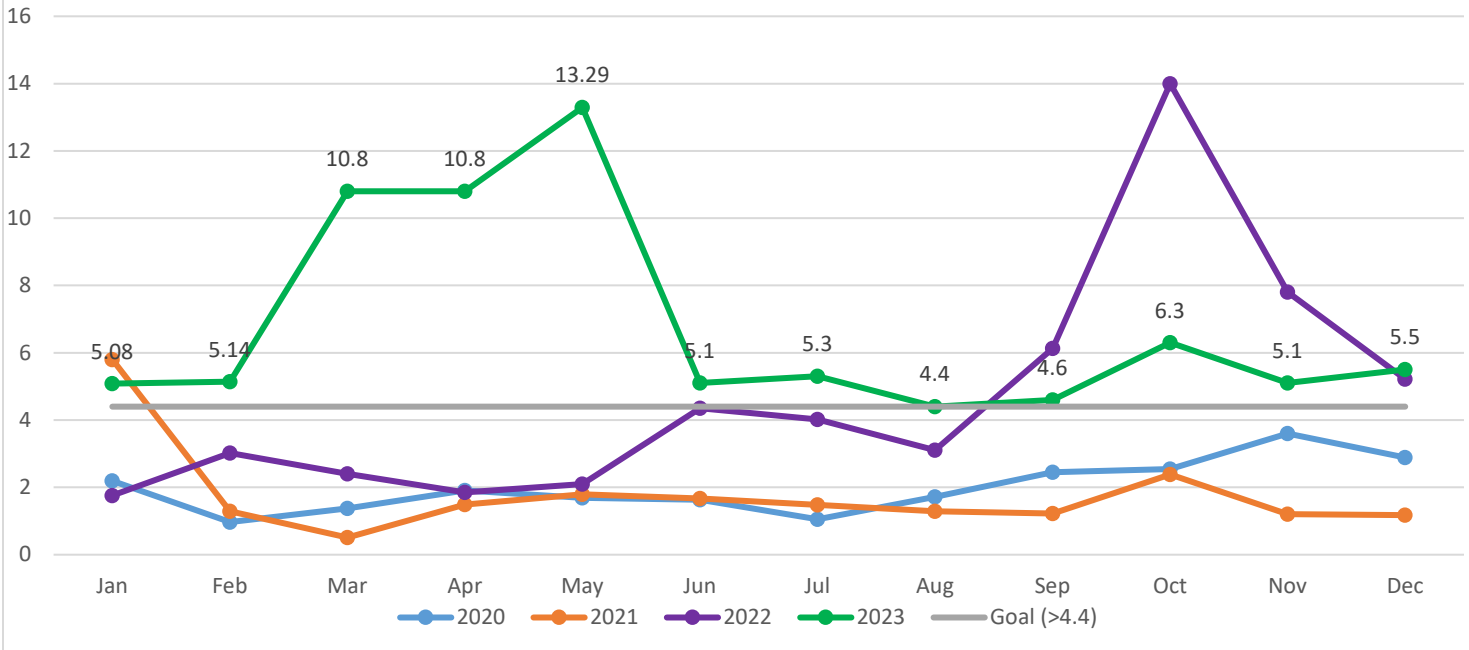
### Average Saturday Ridership - Fixed Route



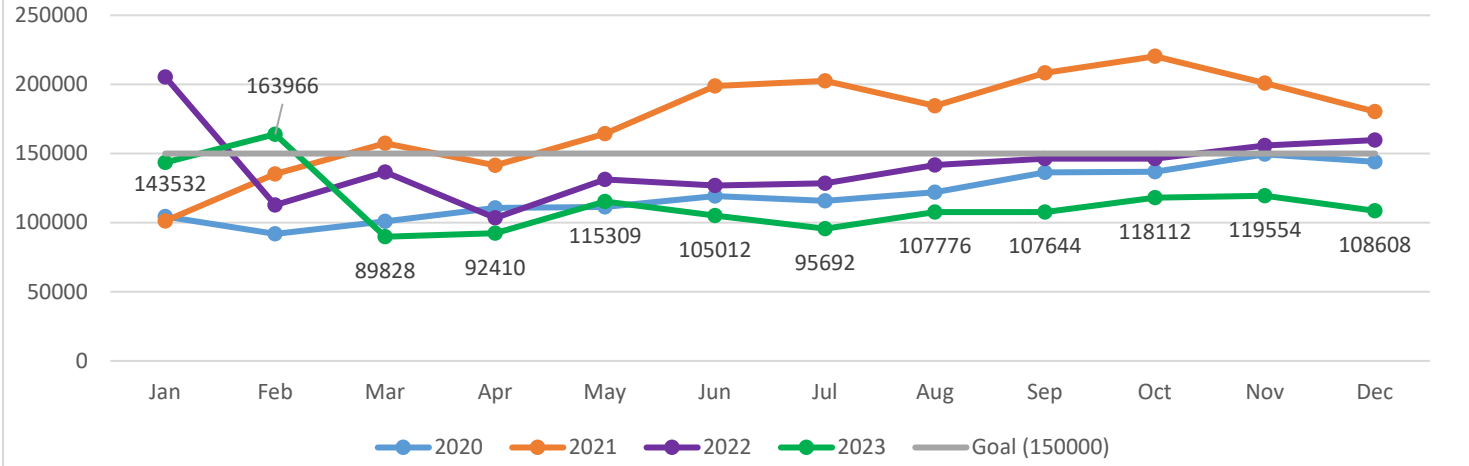
### Average Sunday Ridership - Fixed Route



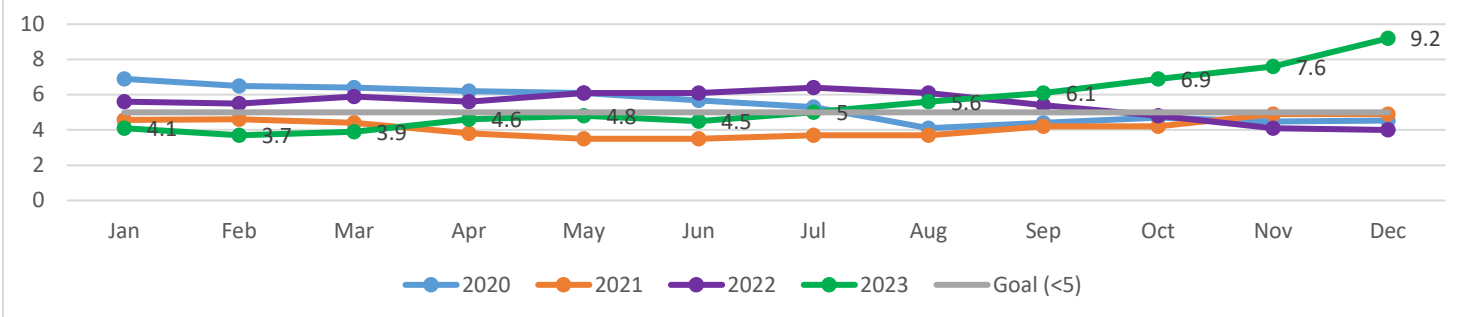
### Training Hours Per Employee
